In accordance with the Right to Privacy Act, we will not discuss your account with any person or persons other than the name(s) appearing on the bill. The only exception would be by court order or your written permission. Bill due date is 20 days from the date bill is mailed. Photo I.D. is required. With your approval Kiamichi Electric Cooperative will do a credit check on your credit history. A deposit will be required if your credit score exceeds our limits or if you elect not to have a credit check completed. This deposit is calculated as two month's billing. The meter deposit will be recalculated if payment is late more than twice in 12 months. Connect fee is non-refundable.

Application for Membership and Electric Service

The undersigned (hereinafter called the "applicant") hereby applies for membership in, and agrees to purchase electric energy from Kiamichi Electric Cooperative, Inc. (hereinafter called the Cooperative"), upon the following terms and conditions:

1. The Applicant will pay to the Cooperative the sum of \$ _____ which, if this application is accepted by the Cooperative, will constitute the Applicant's membership fee of \$5.00 and Applicant's meter deposit of \$ _____.
2. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used in the premises described below and will pay therefore monthly at rates to be determined from time to time in accordance with the bylaws of the Cooperative; provided, however, that the Cooperative may limit the amount of electric energy which it shall be required to furnish the Applicant. The Applicant will pay a bill of at least \$ _____ per month regardless of the number of kilowatt hours consumed.
3. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the Cooperative.
4. The Applicant will comply with and be bound by the provisions of the articles of incorporation, the articles of conversion, and bylaws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative.
5. The Applicant, by paying a membership fee and becoming a member, assumes no liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the laws, his private property is exempt from execution for any such debts or liabilities.
6. The Applicant shall be required to pay a minimum bill for two months service for each connected meter.
7. The Cooperative shall use reasonable diligence to provide a constant and uninterrupted supply of electric power and energy; but if such supply shall fail or be interrupted, or become defective through an act of God, or inability to secure right-of-way, or other permits needed, or for any other cause beyond the reasonable control of the Cooperative, the Cooperative shall not be liable therefore.

The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract electric service shall continue in force from the date service is made available by the Cooperative to the Applicant, and thereafter until cancelled by at least 30 days written notice given by either party to the other. If this application is not accepted by the Cooperative, the total deposit in the amount of \$ _____ will be refunded to the Applicant at the request of the Applicant.

The Applicant further agrees to furnish right-of-way easement for placement of poles to provide this electric service. If the Applicant is a tenant and not the property owner, he agrees to assist in securing such right-of-way easement as required to construct the service.

Applicant hereby agrees that \$2.52 of the amount paid for electricity each year is for a subscription to *Oklahoma Living* magazine, a monthly publication for the members of Oklahoma's Rural Electric Cooperatives. This charge is to apply to the Membership Account only.
